

Clarification around eligibility criteria

Exclusion criteria (at screening): Injuries affecting more than one digit or the thumb

Please include

- One digit injured only with both FDS/FDP tendons severed.
- Multiple digits injured only one digit with both FDS/FDP tendons severed, any other injured digits have superficial injury.
- Multiple digits injured only one digit with both FDS/FDP tendons severed, other injured digit may have a partial tendon injury.



Multiple digits injured – multiple digits with both FDS/FDP tendons severed.

Completing the Screening and Eligibility instrument

Only patients where it is known multiple digits with both FDS/FDP tendons severed should be excluded at screening. All other patients should be recorded as eligible (Q13 of the Screening and Eligibility instrument (Does this injury affect more than one digit, or the thumb?) should be answered "no").

Clarification around blinding arrangements

When completing the operation note / referral to hand therapy / discharge letter, please state "flexor tendon repair performed as per FLARE Trial".

Any details about the operation (e.g. pulley repair) that are not collected on the Primary Surgery Instrument can be recorded in the medical records.
